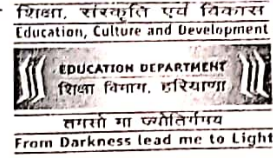

**The school management shall follow-**

1. The provisions of Haryana School Education Act 1995 & Haryana School Education Rules, 2003 and instructions issued by the Department from time to time;
2. The provision of HUDA By-Laws/ Allotment of land conditions.
3. The provision of CBSE By-Laws.
4. Provide reservation in admission as per Rules & Instructions issued by the Government from time to time.
5. Fee structure to be made available to the public and to the Department under the provision of Haryana School Education Rules, 2003.
6. No other charges such as capitation fees shall be taken from the children/ Parent.
7. All disputes and liabilities of Udaya Bharti Public School Sector-14, Faridabad will be of the managing committee of the new school.
8. The name of Udaya Bharti Public School Sector-14, Faridabad will not be used after the issue of this permission.
9. The managing committee of the school will be constituted under rule 32 within 3 months with the approval of the department.
